## FY25 Distribution and 2025 Annual General Meetings

### FY25 Distribution

A distribution totalling 33.0 cents per stapled security will be paid for the six months ending 30 June 2025. This will be paid from Transurban Holding Trust and controlled entities. Transurban Holdings Limited and Transurban International Limited will not pay dividends for the period.

The extent to which distributions paid in FY25 are tax deferred will be confirmed in Tax Statements to be issued with the final distribution in August 2025.

### Distribution Reinvestment Plan

The Distribution Reinvestment Plan (DRP) will operate for the distribution for the six months ending 30 June 2025. No discount will be applied when determining the price at which stapled securities will be issued under the DRP.

The Directors have determined that the DRP pricing period in relation to this distribution will be the period of 10 trading days, commencing 4 July 2025.
